

ORDINANCE NO. 2040-11

AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT CHAPTER 505 OF THE CODE OF THE BOROUGH OF HAWTHORNE, VEHICLES AND TRAFFIC, SO AS TO DESIGNATE STOP AND YIELD INTERSECTIONS AT VARIOUS LOCATIONS WHERE POSTED, AND TO REVISE ARTICLES VIII AND IX, SCHEDULES, SO AS TO ADD THERETO THE SAID LOCATIONS

BE IT ORDAINED by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 505, Vehicles and Traffic, Schedule VIII: Stop Intersections, shall be amended to add thereto additional stop intersections as follows:

Sec. 505-61 Schedule VIII: Stop Intersections

In accordance with the provisions of Section 505-12, the following described intersections are hereby designated as stop intersections, and stop signs shall be installed as follows:

<u>Stop Sign On</u> <u>Of</u>	<u>Direction of Travel</u>	<u>At Intersection</u>
McKinley Avenue Avenue	East/West	Brookside
Florence Avenue	East/West	First Avenue
North 17 <sup>th</sup> Street Avenue	East/West	Westervelt
MacFarlan Avenue Avenue	East/West	E. Prospect
Prospect Street Street	North/South	East 17 <sup>th</sup>
West Prospect Street Street	North/South	East 17 <sup>th</sup>
Chopin Place	East/West	Mazur Place
Midland Avenue	East/West	Wagner Place

Section 2. Chapter 505, Vehicles and Traffic, Schedule IX: Yield Intersections, shall be amended to add thereto additional yield intersections as follows:

Sec. 505-62 Schedule IX: Yield Intersections

In accordance with the provisions of Section 505-

13, the following described intersections are hereby designated as yield intersections, and yield signs shall be installed as follows:

<u>Yield Sign On</u>	<u>Direction of Travel</u>	<u>At Intersection Of</u>
Dogwood Lane	North/South	Sunrise Drive
N. Ethel Avenue	North/South	North 4 <sup>th</sup> Avenue

Section 3. All parts and provisions of Section 210 not specifically affected by the above amendments and modifications shall remain in full force and effect.

Section 4. This Ordinance shall take effect twenty (20) days after final adoption and publication as provided by law.
