MINUTES OF THE WORK SESSION MEETING  
OF THE HAWTHORNE ZONING BOARD OF ADJUSTMENT  
DECEMBER 20, 2010

The December 20, 2010 work session meeting of the Hawthorne Zoning Board of Adjustment was called to order at 7:00 p.m. by Chairman Hallock. All members were present except Messrs. Terraglia and Silvestri. In addition, Charles C. Collins, Jr., Attorney/Secretary, was present.

The Board indicated approval of the bills of the Hawthorne Press and the Board Secretary as well as the minutes of the meeting of November 29, 2010.

Mr. DeRitter raised a question whether he should attend the public hearing in Wyckoff on the Christian Health Care application and the consensus was in the negative since the matter would eventually be coming to this Board for action.

It was agreed that the continuation of the Puddingstone Goffle Holdings application would be on February 28, 2011 with a possible special meeting thereafter.

A discussion followed on the procedure to render a decision on the Patriot Development application and Mr. Collins agreed to provide the Board with a memo outlining the issues involved.

The Board reviewed and approved the proposed 2011 meeting schedule.

Finally, Mr. Hallock asked that Mr. Collins advise the Patriot Development attorney to submit his response to the Board's planning testimony at least ten days before the January hearing date.
