

ORDINANCE NO. 2346-24

AN ORDINANCE TO FIX THE 2024 SALARIES, WAGES AND COMPENSATION OF THE EMPLOYEES OF THE BOROUGH OF HAWTHORNE, COUNTY OF PASSAIC AND STATE OF NEW JERSEY.

The Municipal Council of the Borough of Hawthorne in the County of Passaic and the State of New Jersey, do ordain as follows:

Section 1. Ordinance No. 2342-24 of the Borough of Hawthorne, an Ordinance to Fix the Salaries, Wages and Compensation of the Employees of the Borough of Hawthorne, County of Passaic and State of New Jersey, is hereby amended as follows:

Section 2. There shall be paid to all the full-time dispatchers of the Hawthorne Police Department in the current year, \$ 325.00 annually, as a clothing allowance.

Section 3. There shall be paid to all the full-time dispatchers of the Hawthorne Police Department in the current year, holiday pay for three (3) holidays: New Year’s Day, Thanksgiving, and Christmas.

Section 4. All ordinance and parts of ordinances inconsistent with the provision of this ordinance be and the same are hereby repealed, but only to the extent of such inconsistencies.

Section 5. This ordinance shall take effect twenty (20) days after final passage, provided notice of the same has been duly published all as required by law.
