

ORDINANCE NO. 2369-25

AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT CHAPTER 505, ARTICLE II, SECTION 505-6, ONE-WAY STREETS, SCHEDULE 505-55, SO AS TO ADD THERETO CERTAIN ADDITIONAL LOCATIONS

BE IT ORDAINED by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 505, Vehicles and Traffic, Article II, Section 505-6, One-Way Streets, Schedule III, Section 505-55, shall be amended to add thereto the following additional locations:

Sec. 505-57, Schedule III: One-Way Streets

In accordance with the provisions of Sec. 505-6, the following described streets or parts of streets are hereby designated as one-way streets in the direction indicated:

<u>Name of Street</u>	<u>Direction of Travel</u>	<u>Limits</u>
North 8 th Street	South	From the intersection at Goffle Road South to the Prospect Park border at Prescott Avenue. <i>This Ordinance shall be effective for a period to run from effective date* to July 7, 2025 and thereafter shall expire without any further action to be taken.</i>

Section 2. All other parts and provisions of Section 505, Schedule III, not specifically affected by the above amendments and modifications shall remain in full force and effect.

*Section 3. This Ordinance shall take effect twenty (20) days after final adoption and publication as provided by law.
