

**ORDINANCE NO. 2371-25**

**AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT CHAPTER 505, VEHICLES AND TRAFFIC, ARTICLE II, TRAFFIC REGULATIONS, SECTION 505-16, TRUCKS OVER CERTAIN WEIGHTS EXCLUDED, SO AS TO MODIFY THE DEFINITIONS CONTAINED THEREIN, AND SECTION 505-65A, SCHEDULE XII, SO AS TO ADD ADDITIONAL LOCATIONS THEREUNDER**

**BE IT ORDAINED** by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 505, Vehicles and Traffic, Article II, Traffic Regulations, Section 505-16, Trucks Over Certain Weights Excluded, Section A, shall be repealed and replaced, the said Section to read as follows:

Sec. 505-16. Trucks over certain weights excluded.

- A. Trucks over certain weights excluded. Trucks in excesses of the gross vehicle weights indicated, as determined by the vehicle's Gross Vehicle Weight (GVW) or Registered Gross Vehicle Weight (RGVW), are excluded from the streets or parts of streets described in Schedule XII, (§505-65A), except for the pick-up or delivery of materials on such streets.

Section 2. Chapter 505, Vehicles and Traffic, Article X, Schedules, Section 505-65, Schedule XII, Trucks Over Certain Weights Excluded; Through Trucking, Subsection A, is hereby amended so as to add the following additional locations thereunder:

Section 3. All other parts and provisions of Chapter 505 not specifically affected by the above amendments and modifications shall remain in full force and effect.

Section 4. This Ordinance shall take effect twenty (20) days after final adoption and publication as provided by law.
