

ORDINANCE NO. 2372-25

AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT CHAPTER 505, VEHICLES AND TRAFFIC, ARTICLE I, GENERAL PROVISIONS, SECTION 505-3, VIOLATIONS AND PENALTIES, AND VARIOUS ADDITIONAL SECTIONS NOTED HEREUNDER, SO AS TO SET FORTH PENALTIES FOR CERTAIN VIOLATIONS UNDER SAID CHAPTER

BE IT ORDAINED by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 505, Vehicles and Traffic, Article I, General Provisions, Section 505-3, Violations and Penalties, shall be repealed and replaced, the said Section to read as follows:

Sec. 505-3. Violations and Penalties

- A. Unless another penalty is expressly provided by New Jersey Statute or this Ordinance, every person convicted of a violation of a provision of this Chapter or any supplement thereto shall be liable to a penalty of not more than \$100 or more than 30 days in prison, or both.

- B. Violations of the following provisions of this Chapter shall, upon conviction, result in the imposition of the penalty set forth in connection therewith.

- C. In addition to penalties set forth above, any violator of any of the aforesaid parking sections may be towed at the expense of the owner of the vehicle.

Section 2. All other parts and provisions of Chapter 505 not specifically affected by the above amendments and modifications shall remain in full force and effect.

Section 3. This Ordinance shall take effect twenty (20) days after final adoption and publication as provided by law.
