

**ORDINANCE NO. 2374-25**

**AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT CHAPTER 505, ARTICLE II, SECTION 505-6, ONE-WAY STREETS, SCHEDULE 505-55, SO AS TO ADD THERETO CERTAIN ADDITIONAL LOCATIONS**

**BE IT ORDAINED** by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 505, Vehicles and Traffic, Article II, Section 505-6, One-Way Streets, Schedule III, Section 505-55, shall be amended to add thereto the following additional locations:

Sec. 505-57, Schedule III: One-Way Streets

In accordance with the provisions of Sec. 505-6, the following described streets or parts of streets are hereby designated as one-way streets in the direction indicated:

<u>Name of Street</u>	<u>Direction of Travel</u>	<u>Limits</u>
North 8 <sup>th</sup> Street	South	From the intersection at Goffle Road South to the Prospect Park border at Prescott Avenue

*This Ordinance shall be effective for a period to run from September 8, 2025 to December 8, 2025 and thereafter shall expire without any further action to be taken.*

Section 2. All other parts and provisions of Section 505, Schedule III, not specifically affected by the above amendments and modifications shall remain in full force and effect.

Section 3. This Ordinance shall take effect twenty (20) days after final adoption and publication as provided by law.
